That portion of Fern Dale Drive bounded on the west by Lot 31 in Idlewood Beach, on the south by that portion of Fern Dale Drive previously abandoned and discontinued by the Ottawa County Board of Road Commissioners, as recorded in Liber 591, page 580 of the Register of Deeds office of Ottawa County, and bounded on the east by Lots 35, 39, and on the north by Michigan Avenue, Idlewood Beach Subdivision, Park Township, Ottawa County, Michigan.

IT IS FURTHER ORDERED AND ADJUDGED that the Plaintiff shall prepare, in the form required by the Statutes of the State of Michigan for a final plat, a new plat of that part of the Subdivision affected by this Judgment and shall record the same with the Ottawa County Register of Deeds Office, except, however, the Plaintiff shall not be required to replat Lot 35 of the plat of Idlewood Beach Subdivision.
